The bid meets the conditions for participation in the Tender Procedure and does not contain an abnormally low bid price.

## Justification:

I.

On 15 May 2024, the Tender for the above mentioned Public Contract was launched by publishing the Invitation to Tender, including the tender documentation, on the profile page of the Contracting Authority.

The bids were to be delivered to the address of the contact point of the person representing the Contracting Authority, i.e. to TENDERA partners, s.r.o., Česká 161/1, 602 00 Brno, by 17 June 2024, 10:00 a.m. at the latest.

The Contracting Authority received a total of 1 bid within the deadline.

In order to assess meeting of conditions for participation in the Tender and to evaluate the bids, the Contracting Authority established an evaluation committee (hereinafter referred to as the "Committee") that assessed meeting of conditions of participation in the Tender on its meeting on 28 June 2024 (hereinafter referred to as "meeting").

In relation to the conclusions reached when assessing the qualification and bid of the Tenderer, the Committee was supposed to evaluate the bids according to the rules for evaluation of bids specified in Art. 5 of the tender documentation. Rules for evaluation of bids stipulated that the submitted bids will be evaluated according to their economic merit based on the most favourable bid price-quality ratio using evaluation criteria with the following weights:

Evaluation criteria	Weight of the criterion
Bid price in CZK excluding VAT	50%
Warranty period in months	30%
Guaranteed service request response time in hours	20%

Since the Contracting Authority received only one bid from the participant **Industrial Marketing Corporation S.A.**, the Committee did not perform the bid evaluation in terms of economic merit within the meaning of Section 122(2) of the Act on public procurement, but only declared that the received bid of the participant met the requirements set by the Contracting Authority and is, therefore, acceptable and recommended to the Contracting Authority to decide on the selection of this bid.

The Contracting Authority agreed with conclusions of the Evaluation Committee and therefore decided as stated above.

III.

In accordance with Article 14 of the tender documentation, the Contracting Authority reserved the right to publish a notification regarding the selection of the Contractor on the Contracting Authority's profile page.

In this case, the notification shall be deemed delivered to all tenderers upon its publication.
