Justification:

In the follow-up to the conclusion made within the assessment of meeting the conditions of the participation, the Commission was supposed to perform the evaluation of the bids according to the rules for the assessment of the bids specified in Article VI. of the ordering documentation. The delivered offers were supposed to be assessed on the basis of the economic advantageousness, namely according to the following criteria with the said weights:

Individual evaluation criteria	Weight of evaluation criterion
Offered price in CZK without VAT	70 %
Term of preliminary acceptance of the equipment in weeks from the signature of the contract on performance the subject of the order	30 %

With respect to the fact that the Customer received only one offer of the Applicant **CHUN ZU MACHINERY INDUSTRY CO., LTD.**, the Commission did not realize the assessment of the bid according to the economic advantageousness; it only stated that the received offer of the Applicant met the conditions for the participation and, therefore, was acceptable, and it recommended the Customer to decide about the selection of the said offer.

The Customer has identified itself with the opinion of the Evaluation Commission and, therefore, it has decided as it is stated above.

In compliance with Article XV. of the ordering documentation, the Customer reserved the right to publish the announcement about the selection of the most suitable offer on the profile of the Customer. In such a case, the announcements shall be considered delivered to all Applicants in the tender as of the moment of the publication thereof.

Instructions: In compliance with the Rules for the selection of suppliers within the Operation Programme Enterprise and Innovations for Competitiveness, no remedial measure against this decision is permissible.
