In accordance with the provisions of Art. 12 of the tender documentation, the contracting authority hereby provides explanation of the tender documentation for the public contract indicated above.

I.

Over the course of the period for submission of offers, the contracting authority found several items of information in the document designated as D.1.2.1 Technical report (part of appendix no. 3 to the

tender documentation – project documentation) which were at variance with the remaining parts of the project documentation. For this reason, the contracting authority is issuing this document in its updated form and remedying the discrepancies which were found.

II.

On the basis of this explanation, the contracting authority issues the following part of appendix no. 3 to the tender documentation (project documentation) in the new form:

- D.1.2.1 Technical report2

Each tenderer is obliged in its offer to base its offer on or use this updated version of the appendix. Failure to use this updated appendix shall be regarded as failure to meet the requirements of the tender documentation and such a tenderer will be excluded from the procurement procedure.

III.

In relation to provision of this explanation of the tender documentation, the contracting authority has decided to extend the deadline for submission of offers and replaces Art. 10 para. 3 and Art. 11 para. 1 of the tender documentation with the following wording:

Article 10. Method of submission of offers

3. The offer shall be delivered to the address of the contact point of the party representing the contracting authority, i.e. to the address **TENDERA partners, s.r.o., Jánská 448/10, 602 00 Brno, no later than 10:00 a.m. on 11 June 2021**. The tenderer may send its offer to the above-mentioned address by post or submit it in person on working days between the hours of 8:00 a.m. and 3:30 p.m. and on the last day of the deadline for submission of offers between the hours of 8:00 a.m. and 10:00 a.m.

Article 11. Opening of offers

1. The commission established by the contracting authority shall open envelopes with offers immediately after the deadline for submission of offers has expired and check them at its **public meeting** held at the address of the contact point of the party representing the contracting authority at 10.00 a.m. on 11 June 2021.
