Justification:

Following the conclusions reached in the assessment of the fulfillment of the conditions of participation, the Commission should have carried out an evaluation of the tenders in accordance with the rules for the evaluation of tenders referred to in Article VI. tender documentation. The bids received should be evaluated by economic advantage on the basis of the **lowest bid price. The total bid price without VAT was decisive for the evaluation.**

Since the contracting authority received only one tender from **PICO INTERNATIONAL LLC (DMCC BRANCH)**, the commission did not carry out an economic evaluation of the tender, merely finding that the bid received by the tenderer met the contracting authority's requirements and was therefore acceptable and recommended the contracting authority to decide.

The contracting authority agreed with the opinion of the evaluation committee and therefore decided as above.

In accordance with Article XV. the tender documentation reserved the right to publish on the contracting authority's profile the announcement of the selection of the most suitable tender. In such a case, the notices shall be deemed to have been delivered to all tenderers at the time of their publication.

Lessons learned: In accordance with the Rules for the selection of suppliers in the Operational Program Enterprise and Innovation for Competitiveness, no appeal is possible against this decision.
